



## **Anand Gautam's Summary**

Anand Gautam has recently taken a position of Sourcing Director at Novo Nordisk, Denmark to help bring-in novel biologics to treat autoimmune diseases.

Prior to joining Novo Nordisk, Anand had formed OmGenix BioSolutions, a consultancy company, with the a vision to improve the success rate of drugs from Discovery to Commercialization

Previously, Anand worked as a VP of R & D at Progen, Brisbane, managing and initiating Phase I to III clinical trials in consultations with the FDA. In addition, he led the Discovery team to identify novel compounds for further development.

Anand Gautam has a strong background in the commercial management of international research at various Biotechnology companies and academic institutions. Anand completed his PhD from the University of London in 1990 followed by post-doctoral training at Stanford University, California, USA. Anand was appointed a Research Fellow and later a Leader at John Curtin School of Medical Research, The Australian National University (ANU). In 1998, Anand joined Pharmexa, Denmark, as a Director of Immunology and was soon promoted to become a Senior Vice President of Research – External Collaboration. In this role, Dr Gautam managed the Company's internal vaccine research programs, and external collaborations with a number of large and midsize Pharmaceutical companies. As part of his role at Pharmexa, Anand's responsibilities also included communicating Pharmexa's R&D activities to potential investors and pharmaceutical industry partners. Upon his return to Brisbane, Australia in 2003, Anand worked as a Chief Scientific Officer at Coridon Private Ltd, Chief Operating Officer for a new start-up company, Dendright and was appointed as an Associate Professor at Centre for Immunology and Cancer Research, University of Queensland, Brisbane.
